Fee(s) Time Trial fee is \$20.00** per rider. U12 will be \$5.00. All participants except for U12 must have a valid and current USCF License which **MUST** be presented at the registration table. Numbers will be worn on the right side. A one-day license is available at the registration table for \$10.00. **All** entry fees include \$2.00 USCF insurance fee and \$1.00 for the Kansas Cycling Association Improvement Fund.

Rules: All USCF Rules apply. **ALL** participants **MUST** have their helmets on at all times while riding their bike *before, during, and after* in the race area.
